## Classes offered:

Sunday Trial 1: Instinct, Novice, Open, Senior, Master

Trial entry limits: 120 runs or 8 hours per judge per day.

Pre-entry fees: Instinct \$10; Novice-Senior \$10; Master \$10

Entries open November 1, 2018. Entries at the above fees will be accepted in the order received until closing date of December 13, 2018 with the Trial Secretary or until the maximum entry limit is reached. Late and Day of Show entries will be accepted until trial limit is reached.

# **DIRECTIONS TO SITE:**

From the East/West: Take I-680 to the 72<sup>nd</sup> Street exit; drive north approximately 1.3 miles; Companion Dog Club is on the west side of 72<sup>nd</sup> Street.

# **EXHIBITOR INFORMATION:**

All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50.00 fee for all returned checks.

Dogs may enter any class they wish for which they have already obtained a title or are working on that title. Multiple entries are allowed (maximum of two per dog per class).

All dogs must be on a short leash and under control while on trial grounds. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Collars/harnesses which can be easily and quickly removed and replaced are strongly encouraged. Please bring a secure crate for your dog to relax in during times when they are not in the ring or are left unattended.

There is no smoking in the facility or on the grounds. If you must smoke, you will need to do so inside your vehicle and dispose of the butts in the vehicle also. Dog exercise areas will be marked. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

Dogs are not required to have a Barn Hunt Registration number to participate in this Fun Test. However, you can register your dog online at <a href="https://www.barnhunt.com">www.barnhunt.com</a> for future events.

The running order and further scheduling details will be emailed to all competitors after the Fun Test closes and the actual number of entries in each class is known. The Committee reserves the right to change running order based on entries. Any judge listed in the premium is eligible to judge any classes offered.

Dogs being handled by the same person will be separated into different staged groups.

Height Divisions: Dogs 13" and under - Small

Dogs 13.1 to 18" - Medium Dogs over 18" - Large

**Awards:** Special ribbons and/or prizes may be awarded at the end of the Fun Test.

This Fun Test will be held indoors in a heated building. All rings will be fully matted. Crating space is available, but make sure your crate is secure as the dogs may be highly excited. You may wish to bring a ground cover.

Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Committee deems the exhibitor to be in violation of the requirement per the BHA rules and regulations.

**Bitches in Season ("BIS"):** Bitches in season are eligible to enter but are required to be kept separate from all other dogs. Any BIS is required to run in panties and at the end of their class. Entry fees for bitches that come into season will be refunded until December 14, 2019 if you wish to withdraw. No entry fees will be refunded after that date. If bringing a BIS, you must inform the Committee prior to the trial and all exhibitors at the judge's briefing.

**Loud/Disruptive Dogs:** Dogs that are loud and disruptive may be asked to locate away from the rings/crating area. Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or Committee. Terrier sparring is not allowed anywhere on the trial grounds.

**Refunds:** No refunds will be made after the entry deadline unless there is a replacement entry available. Entry fees will not be refunded if a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee. No refunds of entry fees if the trial cannot open or be completed because of riots, civil disturbances, fire, acts of God, public emergency, public event or any other cause beyond the control of the Trial Committee.
