**New to Barn Hunt?** Then the morning session (9:00 a.m. to 12:30 p.m.) is for you. This session will cover the basic Barn Hunt Association rules and procedures, along with getting your dog experience with meeting and hunting rats. Working spots are \$20 per dog with a limit of 20.

**Getting further up in the Barn Hunt Levels?** Our afternoon session (1:00 p.m. to 4:00 p.m.) will cover the Barn Hunt rules and procedures for the Open, Senior and Master levels, including tips/training for getting better indications when your dog is on a rat, tunneling and reading your dog to know when they are clear (for those Master people). Working spots for the afternoon session are \$20 per dog with a limit of 20.

Auditing either session or the entire day is \$10 per person. If you have a working spot in either the morning or afternoon session, auditing the other session is included in your working spot fee.
