Saturday, September 12, 2020

(This test will be run just like a regular Barn Hunt trial – but we are holding it to fulfill Kris' requirements to become an official Barn Hunt judge. All COVID-19 Barn Hunt rules will apply)

Classes offered:

Instinct, Novice, Open, Senior, Master

Trial entry limits: 120 runs or 8 hours per day.

**Entry fees** (on or before September 4, 2020): \$5.00/run of \$20.00 for a 5-run bundle (get 5 runs for the price of 4)

Entry fees (after September 4, 2020): \$7.00/run (no bundle discount)

Entries open August 12, 2020. Entries at the above fees will be accepted in the order received until the maximum entry limit is reached. Late and Day of Show entries will be accepted until trial limit is reached. No wait lists will be kept if the trials fill.

**DIRECTIONS TO SITE:** From the East/West: Take I-680 to the 72<sup>nd</sup> Street exit; drive north approximately 1.3 miles; Companion Dog Club is on the west side of 72<sup>nd</sup> Street. The Fun Test will be held in the Companion Barn Hunt Building to the north of the main building. Parking is available to the east, west and north of the main building.

VOLUNTEERS PLEASE: Volunteers are needed to keep the Fun Test running. If you can help, please let us know. We greatly appreciate it!!!!

### **EXHIBITOR INFORMATION:**

All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50.00 fee for all returned checks.

Handlers may enter their dogs in any class they wish. You may enter any class, multiple classes, the same class more than once or any combination up to 5 runs per dog.

All dogs must be on a short leash and under control while on trial grounds. Please review the BHA rule book for collars/harnesses that are allowed. Dogs must run without collar/leash, per BHA regulations.

There is no smoking in the facility or on the grounds. If you must smoke, you will need to do so inside your vehicle and dispose of the butts in the vehicle also. Dog exercise areas will be marked. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

Dogs are NOT required to have a Barn Hunt Registration number to participate in these Fun Tests. However, you can register your dog online at <a href="https://www.barnhunt.com">www.barnhunt.com</a> for future events.

If you need information on hotels in the area, please let us know and we will be happy to send you a list of hotels that accept well-behaved dogs.

# TRIAL SCHEDULE:

The running order and further scheduling details will be sent to all exhibitors a few days before the date of the test. The Committee reserves the right to change running order based on entries. Dogs being handled by the same person will be separated into different blinds.

Height Divisions: Dogs 13" and under - Small

Dogs 13.1 to 18" - Medium Dogs over 18" - Large

Awards: No ribbons and/or prizes will be awarded at these Fun Tests.

The Fun Test will be held indoors in a climate-controlled building. All crating will be in your vehicle. Please make sure any crates are secure. The Companion Dog Club building will be available for restrooms and hand washing.

Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Committee deems the exhibitor to be in violation of the requirement per the BHA rules and regulations.

**Bitches in Season ("BIS"):** Bitches in season are eligible to enter but are required to be kept separate from all other dogs. Any BIS is required to run in panties and at the end of their class. Entry fees for bitches that come into season will be refunded until September 11, 2020 if you wish to withdraw. No entry fees will be refunded after that date. If bringing a BIS, you must inform the Committee prior to the trial.

**Refunds:** Entry fees will not be refunded if a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee. No refunds of entry fees if the trial cannot open or be completed because of riots, civil disturbances, fire, acts of God, public emergency, public event or any other cause beyond the control of the Trial Committee.

**BHA COVID-19 required waivers** will be available for participants to sign when arriving at the Fun Test. You will not be able to play without a signed waiver.
