DAY OF SHOW ENTRIES: Entries submitted after closing on April 4th are \$15 per run. Entries must be received and paid by April 18th 5:30 PM. CPE number is required.

- If the limit is reached for any/all day(s) by the closing date, the club will contact CPE to have FULL posted to the CPE events page, for any day(s), is required of the club.
- The exhibitor must verify the limit has not yet been reached between the closing date and trial date if planning on attending. Verify by emailing the secretary dogtrialsectary@gmail.com. Note: emails received after noon on April 18th may not be received or answered the day of the trial.

CRATING: There is crating space available indoors on hard surface floor. You can crate out of your vehicle if desired. Parking is convenient to the entrance. No ex-pens. We anticipate the trial will run for a little over 2 hours.

PRIZES AND AWARDS: Qualifying ribbons will be awarded to all dogs receiving a qualifying score. 1st through 3rd place are awarded ribbons. Dogs with No Time/NQ are not eligible for ribbons. New Title ribbons will be awarded. Brag Tags for placements, qualifying runs and all Speedway titles are offered as option to ribbons.

NOTICE TO EXHIBITORS

- *The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- *Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- *It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children.
