ENTRY CANCELLATION, REFUNDS, & WAIT LIST

1. Entry cancellations MUST be received in writing (includes e-mail) prior to the closing of Pre-entries and MUST include the dogs breed, UKC number, and name. Cancellations received by telephone are NOT acceptable. Checks will be shredded.

2. No refunds will be given for invalid entries and dogs entered in the incorrect class after the event is over.

3. No refund of entry fees will be made for entries cancelled after the Pre-entry deadline.

4. No entries will be refunded after the event is closed.

5. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee.

6. A wait list will be established. The first person on the wait list will be given the first opportunity to be entered in the trial in the event of a cancellation of a pre-entered dog. On the day of the trial, if any of the pre-entered dogs are absent, the absentees will be replaced by the first person on the wait list that is present and ready to compete. We will shred the checks of all wait list exhibitors who do not get the opportunity to compete. A full refund will also be reimbursed to any entrant whose entry is replaced by a waitlisted entry.

7. Every effort will be made to find all duplicate entries before processing. If a duplicate entry is processed, however, no refund will be made.

8. Entry overpayments will not be refunded. Exhibitors will need to write a new check. Entries without jump heights or payment will not be accepted.

9. If, because of riots or civil disturbances, it is impossible to open or to complete an event or trial, no refund of entry fees will be made.10. If, specifically because of Nebraska governmental authority or pandemic guidelines, it is illegal or impossible to hold this event, Companion Dog Club Partners will update exhibitors and issue full refunds.

11. Exhibitors understand that they are entering this event at their own and others risk. If an exhibitor needs to cancel entries after the closing date because of his/her own circumstances with COVID-19 exposure, special consideration will be given. Please contact the secretary. 12. If, in the opinion of the host club, the well-being of dogs, exhibitors, or spectators is at risk due to extreme weather conditions, such as, but not limited to snowstorms, tornadoes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.

Directions to Trial Site

Companion Dog Club is located at roughly 1/2 mile south of Highway 36 & 72nd Street in Omaha, Nebraska. It is 1.2 miles North of the I-680 & 72nd Street Intersection.

The Companion Dog Club facility is a large, white, one story, metal building on the west side of 72nd Street. It is the first building located on the left in the old North Omaha "Radar Center" as you approach from the South. Use the southern gate to access the facility. Parking is in front of the building.

Dogs Eligible to Enter

All dogs must be 6 months or older that are registered with the United Kennel Club are eligible to participate.

Bitches in season, aggressive dogs, blind dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are ineligible to participate. CDC allows dogs owned by club members on the trial committee to enter. This includes the trial secretary.

Safety, Behavior and Liability

- **By entering this trial**, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- The Companion Dog Club Partners & UKI assume no responsibility for any loss, damage, injury, or death sustained by exhibitors, handlers, or to any of their dogs or property, and assumes no responsibility for injury to children not under control of their parent(s) or guardian(s).
- Companion Dog Club Partners may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness, or other cause; and no one shall have any claim or recourse against or any official thereof.
- Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. There will be no refunds of entry fees if a person is asked to leave the trial site.
- All dogs must be on leash or kenneled at all times when not in the ring.
- Exhibitors are expected to comply with the Omaha's Disposal of Dog Waste Ordinance: Any person having custody or control of any dog shall have the responsibility of disposing of dog feces or manure of the dog in a sanitary manner.
- **Crates** may be left overnight; however, the Companion Dog Club will not be responsible for any lost or damaged items left at the show site.
- By entering this trial you are releasing CDC and the trial facility from any impact or consequences of communicable disease. Be kind, respectful, and do your part to ensure safety of yourself, your dogs and other trial attendees.
